### **Terms & Conditions**

- 1. Applicant should submit KYC like self-attested Valid ID Proof and Address Proof along with this application.
- 2. Applicant should collect Pass Book or FD/RD/Pigmy Receipts from the society office.
- 3. Applicant must periodically update your pass book.
- 4. The original Passbook as well as receipts must be surrendered at the time of withdrawal.
- 5. Collection charges @3% per month shall be debited for Pigmy / RD accounts.
- 6. The minimum duration of Pigmy and Recurring deposit shall be One year.
- 7. No interest shall be paid if the account is pre-closed before six months.
- 8. The interest rates shall be varied as per the prevailing rate of interest from time to time as per the decisions of Board of directors of the society.
- 9. Rs.100/- shall be charged for issue of duplicate Pass Book or FD/RD receipt.
- 10. The Instalment for RD scheme shall be paid on or before the due date of every month. If any late payment after due date shall attract penalty @1% per month.
- 11. The FD/RD amount shall be issued after maturity. The Original Receipt/ Passbook shall be surrendered at the society office to initiate the payment.
- 12. For RD/Lakpathy Scheme, if any EMI is paid late for any month, the disbursement is made only after the highest delayed EMI period.
- 13. If the RD cancelled after 6 months and before the maturity date, only the principal amount shall be paid. If the RD cancelled before 6 months, collection charges @3% shall be deducted.
- 14. The disbursement shall be paid only by Cheque/ NEFT/RTGS or Online. Additional Charges as applicable shall be debited for NEFT/RTGS
